CORNTHWAITE GROUP: Cookie Policy

1. INTRODUCTION

- 1.1 Cornthwaite Group is the trading name of the Cornthwaite Group of companies, which includes Cornthwaite Agricultural Limited and all other companies within the Cornthwaite group of companies whose registered address is Hall Lane, Bispham Green, Ormskirk, Lancashire, L40 3SB. Unless expressly specified, all Company policies are applicable to the group of companies, and reference to 'The Company', 'The Group' and 'The Employer' are used interchangeably to mean the Cornthwaite group of companies.
- 1.2 This policy explains how Cornthwaite Group ("company", "we", "us" and "our") uses cookies and similar technologies to recognise you when you visit our website at https://cornthwaitegroup.com ("website"). It explains what these technologies are and why we use them as well as your rights to control our use of them.
- 1.3 In some cases, we may use cookies to collect personal information or that which becomes personal information if we combine it with other information.

2. WHAT ARE COOKIES?

- 2.1 Cookies are small data files that are placed on your computer or mobile device or browser when you visit a website. Cookies are widely used by website owners in order to make their websites work or to work more efficiently as well as to provide reporting information.
- 2.2 Cookies set by the website owner in this case Cornthwaite Agricultural Ltd, are called first party cookies. Cookies set by parties other than the website owner are called third party cookies. Third party cookies enable third party features or functionality to be provided on or through the website e.g. advertising interactive content and analytics. The parties that set these third-party cookies can recognise your computer both when it visits the website in question and also in the visit to certain other websites.

3. WHY DO WE USE COOKIES?

3.1 We use first- and third-party cookies for several reasons. Some cookies are required for technical reasons in order for our website to operate and refer to these as Essential or Strictly Necessary cookies. Other cookies also enable us to track and target the interests of our users to enhance the experience on our online properties. Third parties serve cookies through our website for advertising analytics and other purposes. This is described in more detail below.

4. HOW CAN I CONTROL COOKIES?

4.1 You have the right to decide whether to accept or reject cookies. You can exercise your cookie rights by setting your preference in the cookie consent manager. The cookie consent manager allows you to select which categories of cookies you accept or reject. Essential cookies cannot be rejected as they are strictly necessary to provide you with services. The cookie consent manager can be found in the notification banner and on our website. If you choose to reject cookies you may still use our website, though your access to some functionality and areas of our website may be restricted. You may also set or amend your web browser controls to accept or refuse cookies. The specific types are first- and third-party cookies served through our website and the purposes they performed are described in the table below. (Please note that the specific cookies served may vary depending on the specific online properties you visit).

5. TYPES OF COOKIES

5.1. Strictly Necessary / Essential website cookies

These cookies are strictly necessary to provide you with services available through our website and to use some of its features such as access to secure areas. Strictly necessary cookies enable core functionality such as security, network management, and accessibility. These cookies are required for the operation of our website and are essential as the website will not work properly without them. You may disable these by changing your browser settings, but this may affect how the website functions. If these cookies are disabled you may not be able to access all, or parts, of the website. If you wish to change your cookie settings, please read the 'how do I change my cookies' cookie section further below.

5.3. Analytics / Customization cookies

We would like to set analytics cookies to help us improve our website by collecting and reporting information on how you use it. 5.4. Advertising / Targeting cookies

Targeting cookies are used to record a visit to the website, the pages which have been visited and the links a user has followed. This enables us to use the information gathered to make the website and the advertising displayed on it more relevant to the interests of each specific visitor due to their web browser behaviour. Collected data includes the user's browsing activity, IP address, location, and actions on our website. These online identifiers can constitute as personal data so we will only collect this information with your consent. We do not share the personal data but do share the actionable data with our third-party suppliers (website developer and SEO optimiser) to assist us in improving our visitor experience on our website. This data will be retained in line with our Data Retention Policy and expire as per the table below. Third Party targeting cookies are used to build user profiles by tracking data so that websites can offer their customers the best-suited ads for their needs. Every visitor to our website will have the option to opt-out at any time using the cookie settings provided on our website cookie banner or in your browser settings. 7. TRACKING TECHNOLOGIES LIKE WEB BEACONS

7.1 Cookies are not the only way to recognise or track visitors to our website. We may use other similar technologies from time to time, like web beacons, sometimes called tracking pixels or clear gifts. These are tiny Graphics files that contain a unique identifier that enable us to recognise when someone has visited our website or open an e-mail, including them. This allows us, for example, to monitor the traffic patterns of users from one page within a website to another, to deliver or communicate with cookies, to understand whether you have come to the website from an online advertisement displayed on a third-party website, to improve site performance. And to measure the success of e-mail marketing campaigns. In many instances, these technologies are reliant on cookies to function properly, and so declining cookies will impair their functioning.
